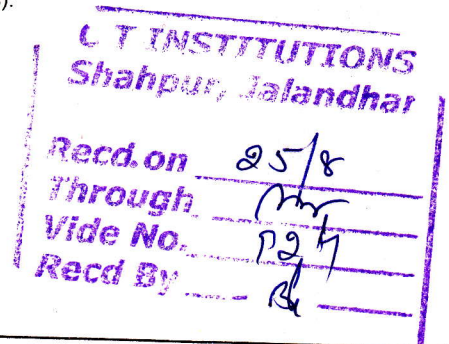
All other terms and conditions in the letter referred above remain unchanged.
